# Chin Hin Property and Atlan Unveil The Eclipse – Redefining Coastal Urban Living in Johor Bahru

Rising on a 4.28-acre site, The Eclipse features two towers ranging from 36 to 58 storeys, housing 1,116 units tailored for practical and modern lifestyles. The architecture draws inspiration from Johor's coastal setting, with streamlined silhouettes and clean vertical lines that establish a distinct presence along the Straits of Johor. Units range from 570 to 1,161 sq ft, offering 1+1 to 3+1 bedrooms, priced from RM630,000.

## **Exceptional Connectivity for a Cross-Border Lifestyle**

Located in Stulang with direct access to major routes, The Eclipse offers strong connectivity for residents and cross-border commuters. The development sits approximately 2.8 km from the CIQ and is within minutes of the upcoming Bukit Chagar RTS Station, which will link Johor Bahru to Woodlands North in Singapore with an estimated travel time of 15 to 30 minutes.

The RTS Link — designed to carry up to 10,000 passengers per hour per direction — is expected to significantly enhance mobility, making Johor Bahru an increasingly attractive residential and investment destination.

Residents will also benefit from access to major routes including the EDL, JB Sentral and Jalan Tun Abdul Razak, as well as nearby lifestyle destinations such Johor Bahru Heritage Street, Johor Bahru City Square, and Mid Valley Southkey.

#### **Design Excellence Rooted in Coastal Context**

The Eclipse is shaped by a team of award-winning consultants who have developed a design approach grounded in its coastal setting. WDA Architects leads the architectural design, introducing a streamlined tower form that maximises natural light and coastal views. The





landscape, designed by Landart Associates, draws from the rhythm of solar and lunar eclipses to create functional outdoor spaces defined by light, shadow and movement. Inside, Ministry of Design (MOD) of Singapore incorporates clean lines and a refined material palette to establish a calm, contemporary atmosphere. Together, the architectural, landscape and interior concepts form a cohesive, design-led experience.

At Level 11, The Eclipse features an expansive facilities deck inspired by celestial movements, offering residents a collection of lifestyle, wellness and leisure spaces designed around the themes of light, water and tranquillity.
